

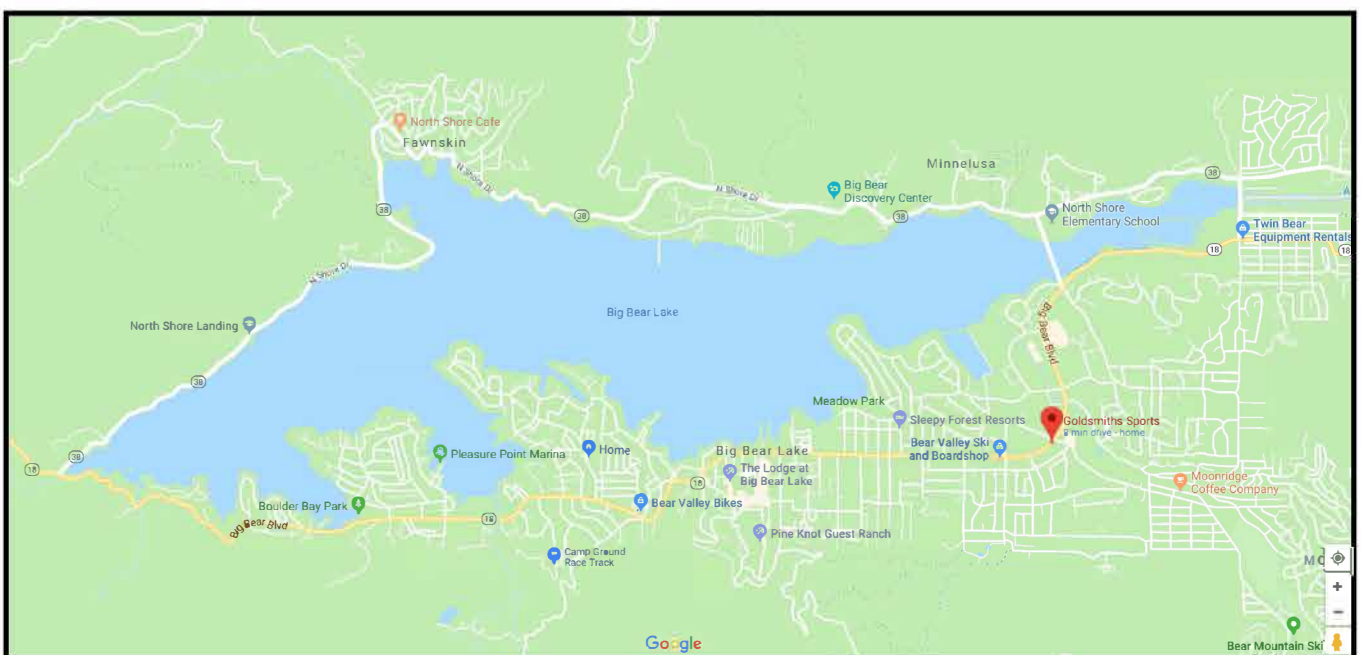

**Alpine, Nordic and Snowboard  
Rental Agreement and Release of Liability**

**1. PLEASE READ CAREFULLY BEFORE SIGNING.**

I accept for use the equipment listed on this form and accept full responsibility for the care of the equipment. I will make no misrepresentations to the service center regarding this user's height, weight, age or skier type.

I understand that skiing in its various forms (alpine, snowboarding, cross-country, snowskating, telemark) are **HAZARDOUS** activities. I also understand that skiing in its various forms have inherent and other risks of injury to any part of this user's body, including death, that reasonable care, caution, instruction and expertise cannot eliminate. I further understand that injuries are common and ordinary occurrences during these activities. I hereby agree to freely, voluntarily and expressly **ASSUME** and accept any and **ALL RISKS** of any injury to any part of the user's body, including death, while skiing in its various forms.

I understand that the Alpine ski equipment being furnished forms a part of or all of a ski-boot-binding system which will **NOT RELEASE OR RETAIN** at all times or under all circumstances, and that its use cannot guarantee this user's safety or freedom from any injury while in use. I further agree and understand that any ski-boot-binding system does **NOT ELIMINATE THE RISK** of injuries to this user's knees or to any other part of this user's body. If Snowskate Snowboard Cross-Country or Telemark equipment is being furnished, I understand that these systems are designed to **NOT RELEASE** and do **NOT PROTECT** against injuries to any part of this user's body including, but not limited to, the wrist, knee or ankle. I hereby **FOREVER RELEASE** Goldsmith's Boardhouse and Ski Rental, its employees and owners, as well as the equipment manufacturers and distributors from, and indemnify them and hold them harmless for any and all responsibility or legal liability for any injuries or damages to any user of any equipment listed on this form, whether or not such injuries or damages are caused by the **NEGLIGENCE** of Goldsmith's Boardhouse and Ski Rental. I agree **NOT** to make a claim against or sue Goldsmith Boardhouse and Ski Rental, as well as the equipment manufacturers and distributors for injuries or damages relating to skiing, snowskating or snowboarding and/or the use of this equipment and accept full responsibility for those injuries or damages.

Goldsmith Boardhouse and Ski Rental, itself, provides **NO WARRANTIES**, express or implied, and this equipment is accepted "**AS IS**". I have carefully read this agreement and release of liability and fully understand its contents. This document constitutes the final and entire agreement between Goldsmith Boardhouse and Ski Rental and the undersigned.

I understand that a helmet designed for **RECREATIONAL SNOW SPORT** use will help reduce the risk of some types of injuries to the user at slower speeds. I recognize that serious injury or death can result from both low and high energy impacts, even when helmet is worn.

I have carefully read this agreement. I am aware that this is a binding contract which provides a comprehensive release of liability. However, it is not intended to assert any claims of defenses that are prohibited by law. This agreement is governed by the applicable law of this state or province. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect. I will also read Part 3 of this agreement and will be responsible for obtaining all of the information referred to in that section and provide it to the user of this agreement.
